CONDITIONS AND LIMITATIONS:

- Permits, including Zoning Permits **not** involving development, shall expire if the authorized work or Use is not commenced within, or if work is suspended or abandoned for period of, **six (6) months from the date of issuance** with the following exceptions:
 - 30-days or 10-days** for Permits related to Unsafe or Imminently Dangerous properties respectively.
 - 3-years** from issuance or date of decision by ZBA for Zoning Permits involving development.
 - 60-days** for Plumbing, Electrical or Fire Suppression Rough-In Approvals.
 - Any Permit issued for construction or demolition is valid for no more than **five (5) years**.
- All provisions of the Philadelphia Code must be complied with, whether specified herein or not. This permit does NOT constitute approval of any Violation of such Code.

FOR A EATING AND DRINKING ESTABLISHMENTS AT FIRST FLOOR IN THE SAME BUILDING WITH MULTI-FAMILY HOUSEHOLD LIVING (146 DWELLING UNITS) FROM SECOND FLOOR THROUGH SEVENTH(7TH) FLOORS WITH TWENTY-NINE(29) ACCESSORY PARKING SPACES INCLUDING WITH FOUR(4) AUTOSHARE SPACES; TWO(2) ACCESSIBLE SPACES INCLUDING WITH ONE(1) VAN ACCESSIBLE SPACE; TWO(2) RESERVOIR SPACES AND ONE(1) ELECTRIC VAN PARKING SPACE AND WITH SEVENTY-TWO(72) BICYCLE SPACES IN AN ACCESSIBLE ROUTE AT FIRST FLOOR.

CONDITIONS

This Zoning Permit (ZP) shall expire if construction or operation pursuant to the permit or approval has not begun within three years after the date the permit or approval was granted.

Changes of use shall be valid for a period of six months unless an application for a Certificate of Occupancy is submitted for that use within such period.
